RULES AND REGULATIONS GOVERNING THE USE OF GUEST ROOMS

- (a) The Guest Room(s) can be booked only by a Member of the Club.
- (b) At the time of booking, the room charge will be paid in advance in addition to Security Deposit of Rs. 500/- per room.
- c) The security Deposit will be refunded after adjustment if any against breakage of Club property and/or any unsettled Bills of the guest(s) occupying the Room(s).
- (d) In case of cancellation of booking the advance will be refunded on the following basis:
 - 75% of the advance will be refunded if the cancellation advice is received by the Club office in writing at least three days in advance of the date of booking and 50% in case of cancellations at shorter notice than three das but up to one days in advance. Cancellations thereafter will entail forfeiture of the entire booking amount. The security Deposit will however be refunded in full in all cases of cancellation.
- (e) The Check-in and cheek-out time will be 12 noon. If check-in is between 6 a.m. to 10 a.m. extra half day room rent will be payable. Subject to availability.
- (f) The guest room occupants can avail of the Restaurant and Bar facilities without any entry/guest charge. Of the other facilities they can avail of gymnasium and swimming pool only and that too on payment of prescribe charge of Guests.
- (g) No food/beverages are allowed to be brought into the Room from outside the Club.
- (h) Members who book the room will be liable for any loss or damage to Club property caused by their guests staying in the Room.
- (I) No unlawful activity will be allowed to be carried on in the Room(s). In such ans event, the Guest shall be asked to vacate the Room.
- (j) The Restaurant, Bar and other Bills should be cleared in cash by the Guest then and there and no usettled Bill should be left while checking out.
- (k) Vehicle will be allowed to be parked inside the Club compound after 11.00 p.m. upto 6.00 a.m. only the parking will be outside the Club at the owner's own risk.
- (I) No Club items will be removed and/or taken out of the room.
- (m) Maximum two persons are allowed to stay in one Room. In case of married couple two minor children will be allowed. However, extra Bedding can be permitted to be laid in the Room @ 100/- only.
- (n) The Guest Room occupant will ordinary follow the Club timings and be back in the Room before the Club closes. However, in exceptional cases by prior intimation to the Club authorities, the Guest may return later than the closing time.
- (o) For any violation of these Rules and Regulations by the Guest the member concerned who had booked Room will be liable and pay penalty as decided upon by the Club authorities.
