

## For New AM Membership

1. **Application Form**
  2. **Copy of Pan Card – Self Attested**
  3. **Copy of Aadhar Card – Self Attested**
  4. **Photo- 2 Nos.**
  5. **Cheque in favour of “ Riverside Sports & Recreation Club”**
- **Any person who have own flat and who is bonafide member in any 22 group housing society (also resident of flat) situated in Mayur Vihar Phase-1 extension are eligible to Ordinary Member (Certificate required from Society office that you are bonafide member in Society and residing in society from since .....)**
  - **Other than Ordinary members are eligible for Associate Membership.**

1. **Application form – Rs.250/-**
  2. **Membership Fee for AM Members (Associate Membership)– Rs. 120,000+ 18% GST = Total Rs.141600/-**
  3. **Life Subscription Rs 29500/- Including GST**
  4. **After Membership – Subscription Rs 885/- Quarterly or You may pay one time Life Subscription Rs 29500/- including GST. There will be no need for subscription payment every month or annually thereafter to you or to your ADD-On Members or to your Transfer member.**
- **Member:-Self (Primary member), Spouse (Dependent Member), Parents (Dependent Member), Children (upto to age of 25 Yrs- Dependent Member).**
  - **Facilities of Club:- Banquet Hall, Restaurant, Swimming Pool,Gymnasium, Bar, Rooms (4 Nos), Billiards, Playing Card Room, Badminton Court. Affiliation with 56 other Clubs in India.**
  - **As per Rule 5(II) of Rules & Regulation of Club you may transfer your Membership**

### **5 (II) TRANSFER OF MEMBERSHIP**

Any member in categories other than Corporate, Donor, Add-On and Temporary may, once during his/her tenure as member, transfer his/her membership, along with Life Subscription, if any, to any one of his/her family members after getting approval from the Managing Committee on Payment of a Transfer Fee of Rs.6, 000/- plus 18% GST Such transferee member is not entitled to transfer the membership again to anyone. The term “family members” would cover parents, spouses, sons and daughters only.

- **After Membership – You may take ADD-On membership for your Children with Nominal Membership Rs 17700/- each.**

(a) **As Per Rule 3 (f) of Rules & Regulation of Club :-** Add-On Membership will be open to any **TWO children** above the age of 21 years, of the Promotee, Promotee Life, Life, Ordinary & Associated Member, who is mentally sound and not convicted for any offence and whom the Managing Committee approves for enrollment as an Add-On Member.
